CSEC INCLUSION PROGRAM - FUNDING APPLICATION

In August 2021, CSEC and the Calgary Flames Foundation announced a \$2 million commitment through the Calgary Flames Foundation to support inclusion, diversity and equality in sport. The CSEC Inclusion Fund will foster greater inclusion and access to sport for BIPOC individuals, people with disabilities, women and girls and the LGBTQ2S+ community through the creation of strategic partnerships and funding available to groups working to promote inclusion in sports.

In order to be eligible to apply for funds, charities and groups must be working to stimulate spontaneous and/or organized participation in sport and recreation through the promotion of diversity and equality, adapted sport and accessibility, girls and women and within the LGBTQ2S+ community. Applicants must be a registered charity operating in southern Alberta to apply.

PLEASE NOTE: As of July 1, 2025, the eligibility to apply for an Inclusion Program fund will change to a two-year cycle. Charities will now be required to wait two years from the date they received their donation before they can apply again.
